# PURPOSE

This policy will provide guidelines form the use, care and welfare of animals used for teaching purposes for Ride Avenue Pre School.

The policy does not include information on student and family dogs on school grounds.



# **POLICY STATEMENT**

VALUES

# RIDE AVENUE PRE SCHOOL IS COMMITTED TO:

- Complying with the legislative requirements that govern the use of animals for educational purposes.
- Providing an educational justification for the use of animals in educational contexts.
- Providing conditions and management appropriate to the behavioural and physical needs of any animals used for educational purposes.
- Ensuring that wherever and whenever animals are encountered in school activities, educators are responsible for assisting students to develop a respect for animals and to understand the ethical issues involved in the use of animals.

### SCOPE

This policy applies to the approved provider, persons with management or control, nominated supervisor, persons in day-to-day charge, early childhood teachers, educators, staff, students, volunteers, parents/guardians, children, and others attending the programs and activities of Ride Avenue Pre School.

Provide an appropriate space for securing caging, away from heavy traffic areas that is secure, has exercise space, hiding areas, access to sunlight, shade, and the correct temperature.	R	R

Ensure good quality food is stored somewhere on site. Bedding, blankets, toys, bowls, chewing materials and grooming equipment may be necessary (depending on the species).	R	R

# **BACKGROUND AND LEGISLATION**

Many educators keep animals in their facilities, either as pets or as part of a teaching program. Pets bring happiness and responsibility. Having a pet at your facility gives children the opportunity to observe, interact and learn about animals. It can be a valuable part of a child's education and care experience, enriching their learning about nature, ecology, and relationships.

When deciding whether to have a pet, there is a lot to consider, such as:

- The amount of time an animal will be alone.
- How holiday care and veterinary treatment will be provided.
- Who is responsible for ensuring that the animal is always well looked after.

While communal responsibility is philosophically appealing, an animal needs competent and consistent care.

It sends a powerful message when a teacher/educator models responsibility for a vulnerable animal as its primary carer and protector. Animals should never be used to teach (as opposed to model) responsibility to children.

Failing to provide suitable conditions, food, water, and security for an animal is no more acceptable in the classroom than in a backyard.

There are many other ways in which children can demonstrate self-governance and commitment, without risks to animal health and welfare.

#### LEGISLATION AND STANDARDS

Relevant legislation and standards include but are not limited to:

- Australian code for the care and use of animals for scientific purposes 8th edition (2013)
- Code of practice for the housing and care of laboratory mice, rats, guinea pigs and rabbits
- General school authorisation licence to keep wildlife
- Prevention of Cruelty to Animals Act 1986 (Vic)
- Prevention of Cruelty to Animals Regulations 2008 (Vic)
- Victorian codes of practice for animal welfare

# DEFINITIONS

The terms defined in this section relate specifically to this policy. For regularly used terms e.g. Approved provider, Nominated supervisor, Notifiable complaints, Serious incidents, Duty of care, etc. refer to the Definitions file of the <u>PolicyWorks</u> catalogue.

#### Animal/Pet

Any live non-human vertebrate (that is, fish, amphibians, reptiles, birds and mammals encompassing domestic animals, purpose-bred animals, livestock, wildlife) and cephalopods (including octopus, cuttlefish and squid).

**Incident:** Any unplanned event resulting in or having potential for injury, ill health, damage or other loss.

**Incident, Injury, Trauma and Illness Record:** Contains details of any incident, injury, trauma or illness that occurs while the child is being educated and cared for by the service, can also be used to record other incidents at Ride Ave Pre School. The Approved Provider must ensure an Injury, Trauma and Illness Record is kept in accordance with *Regulation 87 of the Education and Care Services National Regulations 2011* and kept for the period of time specified in *Regulation 183*.
